For example, the furnace and forge run in excess of 2100 degrees Fahrenheit. Tools can become extremely hot, and sharp edges of glass can appear. For an enjoyable experience for all, "safety first" and "hot-shop etiquette" are emphasized here at the Waterfall Arts Glass Studio.

I acknowledge that this activity may involve utilizing extremely hot equipment and facilities requiring attention to very important production and safety procedures and carries with it the potential for serious injury. The risks include, but are not limited to, those caused by facilities, temperature, equipment, and actions of other people.

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.
